

## TERMS AND CONDITIONS

1. The auction will be conducted by the auction committee duly constituted by the College.
2. A prospective buyer has to submit a **non-returnable "entry fee"** before they are allowed to enter the auction site. The amount of entry fee should be **Rs.500/- or 10% of the up-set price whichever is lower.**
3. Prospective buyers should submit profile as per Annexure-I enclosed with this document. Vendors should submit copy of Aadhar Card, PAN card/TAN/GST No. (if any)
4. Sale/Auction will be on **"As is where basis is"** and **"whatever there is basis"** and no guarantee for its worthiness or quality will be given by the office
5. Bidders are advised to inspect items under auction sale and satisfy themselves regarding the nature/description/conditions/encumbrances/lien/charge/statutory dues etc over the property before participating in the auction
6. **The rate quoted must be higher than or equal to the reserved price/up set value fixed by this office.**
7. The items shall be sold/auctioned to the highest vendor
8. No items, once disposed of to the successful vendor shall be taken back by this office on any condition whatsoever.
9. Any un-cleared or unnoticed materials left over by the purchaser within the premises cannot be claimed later
10. Upon scrutiny of offers in all aspects and fulfillment of all documents the bid acceptance letter will be awarded to the best and highest quoted responsive bid.
11. **Pick and choose method of collection shall not be allowed.**
12. Statutory dues/liabilities/taxes etc. due to the Govt. /Local body shall be borne by the purchaser.
13. Successful bidder shall deposit an EMD of 25% of the bided value on the same day of auction failing which the next successful bidder shall be considered by the committee.
14. The EMD amount should be deposited in Cash/Cheque/DD. The Cheque/DD should be in favor of **"Principal Govt. Autonomous College, Phulbani"** and payable at Phulbani.
15. The EMD of the party is refundable, only after successful completion of the lifting order in case of abandoning the bid even after awarding the lifting order the EMD of the party shall not be refunded.
16. All expenses including incident charges there of shall be borne by the purchaser.
17. The purchaser is obliged to lift all items engaging own labour/machine and following all laws under force and without causing any damage to the college property.
18. Acceptance/sale certificate following all statutory requirements will be issued only after the approved party deposits the total amount in Cash /Cheque on the spot after the quantity is weighed/ determined.

19. If the buyer will deposit the amount in Cheque, acceptance/sale certificate following all statutory requirements will be issued only after the clearance of the Cheque from their respective Bank.
20. The entire items are to be lifted within a period of two (02) days from the date of issue of the bid accord letter.
21. Any delay in lifting the material shall attract a **penalty of Rs.200/- per day** finally culminating in the forfeiture of the EMD.
22. The bidder shall be deemed to have a full knowledge of the site whether he inspects or not and quantum of materials thereon. No discount/reduction or extra charge payments consequent upon any misunderstanding or otherwise shall be allowed.
23. **On failure of the successful vendor in paying the balance amount, the entire deposit amount paid by the vendor shall be forfeited without any notice unless time is extended further in writing by College Authority and scarp materials will be resold**
24. **The entire amount paid by the vendor shall be liable for forfeiture without prior notice, if the successful vendor fails to adhere to the terms and conditions of the Auction/Sale.**
25. All the disputes and differences arising out of and in any way touching the concerning this auction sale (except for which specific provision has been made herein) shall be referred to the competent authority.
26. All disputes are subject to the jurisdiction of Phulbari, Kandhamal
